DEAR FRIENDS,



MINUTES

MINUTES OF THE FIFTY-SECOND ANNUAL GENERAL MEETING HELD ON SUNDAY, 3 OCTOBER 2021 AT 11am IN THE NAVE, GUILDFORD CATHEDRAL

In attendance: 18 Members of The Friends

- I. **WELCOME**: The Chairman formally opened the meeting. The Chairman thanked the Secretary for distributing the papers.
- 2. **APOLOGIES FOR ABSENCE**: Apologies for absence had been received from Muriel Mulvany, Jim Blake and 15 members.
- 3. **MINUTES OF THE ANNUAL GENERAL MEETING HELD ON SUNDAY**, 7th July 2019: The Minutes were proposed as an accurate record of that meeting by the Chair, Dean Dianna Gwilliams; Seconded by Mike Bishop and carried unanimously.
- 4. MATTERS ARISING: There were none.
- 5. **CHAIRMAN'S REPORT AND COMMENTS**: The Chairman commented on the difficulties and challenges we had all faced over the last 18 months, specifically when trying to meet with each other. The Chairman is hopeful of a more exciting 2022 and spoke of the Cathedral's Diamond Anniversary celebrations taking place post-Christmas. She is confident that the Cathedral is moving forward positively.

6. PRESENTATION OF THE ACCOUNTS FOR THE YEAR ENDED 31st DECEMBER 2020

The Treasurer commented that in a difficult year, income had held up surprisingly well. It was slightly lower than 2019 due to several significant legacies being received in that year. Expenditure for social elements was down due to there not being any, whereas grants agreed by the Trustees were slightly up as reported in the accounts.

Overall, the financial position remained almost static because of the substantial financial reserves. The reserves had been managed so that during the course of 2020/2021 the ordinary reserves were separated from the endowment funds because those funds had reduced in spending value. The Treasurer explained that a policy has been adopted by separating the endowment reserves out and putting them in a different place, where they can grow back in value.

With no questions being raised The Report & Accounts were unanimously received by the Members.

- 7. **TO APPOINT THE INDEPENDENT EXAMINER**: Moore (South) LLP for the year ending 31st December 2021 at a fee to be agreed by the Directors. This was proposed by Dianna Gwilliams Seconded by Linda Sharpin and carried unanimously.
- **8. ELECTION OF DIRECTORS** A detailed explanation ensued from the Treasurer as to why a proposal was put forward from the Dean to re-elect Shirley-Margaret Lloyd for a further two years, rather than three. The proposal was rejected and Shirley-Margaret was re-elected to the Board for a further three years, together with Mike Bishop, Angela Townshend, Muriel Mulvany, Jim Blake who had completed 6 years, stands down and Pauline Read was elected to take his place. Proposed by Dianna Gwilliams; Seconded by Mary Morris and carried unanimously.

9. SPECIAL RESOLUTION - TO AMEND THE CONSTITUTION AS FOLLOWS:

The following was discussed and after some clarification from Mike Bishop the Special Resolution was unanimously received by the Members.

- a) To increase the quorum of members for a General Meeting from 5 to 12 [Article 17(2)];
- b) To allow a General Meeting (including an AGM) to be held by electronic means (e.g. by Zoom) or when a physical meeting is held, to allow participation of members by electronic means; the decision as to which option should be adopted (physical, mixed, virtual) to be made by the directors in accordance with prevailing circumstances [Article 15(2)];
- c) To increase the maximum number of directors from 9 to 12 [Article 28];
- d) To replace Articles 34, 37 and 38 [Appointment of directors].
- 10. ANY OTHER BUSINESS Joy Allen raised concern about the Cathedral no longer live streaming or broadcasting choral services. Shirley-Margaret Lloyd endorsed Joy's concerns and reminded attendees that The Friends had contributed a considerable amount to the live streaming equipment, and if a permanent withdrawal, she would expect money to be refunded to The Friends. The Chairman said she was

confident that the withdrawal of live streaming was a temporary measure but at this moment she was not at liberty to explain why the facility had been withdrawn. The Chairman felt it unnecessary to approach Chapter to reimburse any of the funding but it remained an option. She reiterated how grateful the Chapter was to The Friends for the grant and the huge difference it had made to so many people wishing to attend services remotely.

As there was no further business, the Chairman declared the meeting closed at 12 noon.

HONORARY TREASURERS REPORT 2021

Dear Friend,

You will see from the Annual Report that the Friends have done what they could to support the Cathedral during the pandemic. We have done this by focussing on the Friends ability to "advance the Christian religion for the benefit of the public in accordance with the Cathedral statutes", and "to advance the education of the public in religious fabric". This has resulted in our support for various projects related to communication of worship during the pandemic, details of which are in the Annual Report.

We have been able to do this because of the continued generosity of Friends (in addition to annual subscriptions) and some generous bequests from friends who have remembered us in the Wills.

Subscriptions are dropping, and we are looking to enlarge our membership and find new ways of working with the Cathedral, within our charitable objects. Our unrestricted reserves remain at a level which will enable us to respond to appropriate requests from Chapter – at least for the time being.

We have managed to re-start our social events programme following lockdowns – I hope I may see you at some future events!
